- Moving forward, I expect you to demonstrate the State Department's commitment to improving the quality of reports generated including their timeliness by ensuring that the reports are generated through e-NIMES. Towards realizing this, am aware that a lot of improvements have been done to the system as well trainings for both MDAs and Counties hence making this dream possible and easy at the same time.
