6) Over and above this, the Guidelines are meant to ensure uniformity in Strategic Planning across public sector institutions and prescribe the process of the plan preparation which entails initiation, development, validation and finalization. 7) I am pleased to note that the strategic plan for the Ministry of Environment, Climate Change and Forestry is aligned to the Revised Guidelines.

8) The 5<sup>th</sup> Generation strategic plans and Annual Performance Contracts are important result-based tools that will be used to monitor and track progress of implementation of the MTP IV priorities.

- 9) The State Department for Economic Planning, the Performance Management Department and other Stakeholders commit to work together to support the Ministry in the implementation and monitoring of the plan.
- 10)As I conclude, I wish to once again congratulate the Ministry of Environment, Climate Change and Forestry on the successful completion and launch of its strategic plan whose implementation

will contribute immensely towards attainment of the Government's aspirations.
