The preparatory process of the MTP IV began in July, 2021 with the development of the Concept Note which was approved by the National Steering Committee in December 2021, providing the roadmap for preparation of the plan. The MTP IV National Steering Committee was formed to provide overall guidance and advice at all stages of production of the plan. The National Steering Committee comprising of all Principal Secretaries and the Solicitor General was chaired by the Secretary to the Cabinet and Head of Public Service.
4. After the current Administration took office in August 2022, the National Steering Committee was reconstituted and the draft MTP IV was presented to the Committee in April, 2023 for adoption.
5. **Your Excellency**, the MTP IV that you are launching today, has incorporated the Government's priorities in all sectors of the economy. I therefore urge all the Accounting Officers to ensure timely implementation of priorities that fall within their respective dockets.
